BILL 1 AND SCHOOL FEES (LORI)

Instructional supplies or materials

If Bill 1 is passed, the definition of instructional supplies or materials will be established in the new school fees regulation.

Included in this category would be fees for:

- textbooks
- workbooks
- photocopying
- printing/paper
- any common fees charged to an entire student body or grade cohort

These common fees are often referred to as, among other titles, instructional fees, instructional materials or basic fees.

BUDGET UPDATE (LORI)

- The government is keeping promise to fund growth.
- There is still a shortfall that results in about 2% less funding across schools.
- Over 75% of all CBE money for our budget is spent on salaries
- Some holds on purchases of "stuff"
- Enrollment drives the dollars
