  - 1). Bylaw Workshop from ASCA was held on April 11, 2017 it was very helpful.

In the workshop we drafted a new set of bylaws which we are putting forward discussion and review. Within these bylaws are a couple of things which we need to clarify in order decide prior to drafting the final version to send out to members prior to our AGM.

The bylaws we have currently (from 2007) contain outdated language and there are differing policies and procedures.

During the workshop we decided to use standard bylaws template created by Alberta School Councils' Association. Within that template, there are key elements that change our current operations and understanding of how the Fundraising Society carries out its work.

# **KEY POINTS**

The Board will be composed of the following Officers and Directors.

**Officers:** President, Vice-President, Secretary, Treasurer- These positions are mandatory.

**Directors:** A maximum of **5** Directors at Large - These positions are optional, and will be filled provided there are Members willing to do so. In saying that as we have consistently had 2 Casino Co-coordinators in place on our current council it is logical going forward these 2 individuals will hold 2 of the Director at Large Positions automatically when voted in as Casino Co-coordinators and will be deemed **Directors of Casino.** 

# Adoption of a Membership Form

All parents/legal guardians of students enrolled at Belfast School are encouraged to become members of the Belfast School Fundraising Society. Other interested persons may become Community members, subject to vested interest and bylaws, as approved by the Society.

The majority of members of the Society will be parents/legal guardians. There are no membership fees.

As a member of the Belfast School Fundraising Society I have the right to:

- ✓ vote at any general (membership) meeting of the Society
- ✓ receive notice of all meetings and fundraising activities
- ✓ serve on committees or chair fundraisers
- ✓ stand for election as an Officer or Director on the Executive

Each parent wants to become a member of the Belfast School Fundraising Society, each must complete and sign this document. See a draft Copy of Membership which we are adopting.

# Voting Changes under new bylaws

Only the elected officers and directors can to vote on such things as allocation of funds, potential fundraisers and day to day operations at **General Monthly Meetings**.

THE MAIN REASON FOR THIS CHANGE COMES DOWN TO LIABILITY.

All members who fill out a membership form can vote at all Special General Meetings and Annual General Meetings. This includes things like Voting in Officers and Directors, Special Resolutions like Bylaw changes, Objects, Removal of Board Members etc.

# We need to determine if the President shall/shall not cast their vote any meeting. WHAT DOES THAT MEAN?

If the President doesn't vote, and there was a tie the motion would be defeated. It could however be re-worded, motioned, and voted on again. It also allows members to not feel influenced by the President's choices and allows for discussion.

If the President votes then he/she can vote and their dedication and hard work has a voice.

Majority Decision: The President shall be able to cast their vote but will do so as the last voter.

# Signing Authority at the Bank

The signing authorities of the financial accounts will be the four elected Officers of the Association. For transparency purposes and to avoid conflict of interest, if an executive member is the recipient of a cheque they cannot be one of the 2 signers.

#### **Audits**

Auditing of Financials of the treasurer and records of the secretary will be reviewed at least once a year. This will be done by 2 members of the Society. The individuals who conduct the audit do not have to have attended a certain number of meetings and will not be an Officer or Director, which we previously thought to be true. An accountant can also audit the books.

#### Insurance

For the purpose of carrying out its objectives, the Society will annually review and carry liability insurance as deemed necessary by the Board.

# Objects of the Society

These are our governing purpose to operate by. Just as our 2007 Bylaws are outdated, so are our objects. We are reviewing our Objects to have them reflect the current Alberta Corporate Registry Guidelines. We are fortunate that Celeste Burdinsky of ASCA has agreed to help us with. These will be posted prior to our AGM.

#### **Next Course of Action**

To prepare and publish the "DRAFT" of BELFAST SCHOOL FUNDRAISING SOCIEY BYLAWS and OBJECTS no less than 21 days prior to our AGM on both the School and Councils websites and Parent Board located inside the school.
